THE ELIZABETH KEARNEY WOMEN'S LEADERSHIP DEVELOPMENT PROGRAM IS A GENDER SPECIFIC PROGRAM DESIGNED TO STRENGTHEN AND ENHANCE THE LEADERSHIP OF WOMEN IN THEIR WORKPLACES AND THE COMMUNITY. IT TAKES A COHORT OF WOMEN THROUGH NINE MONTHS OF FACILITATED LEADERSHIP TRAINING LED BY COMMUNITY LEADERS. EACH PARTICIPANT CREATES AN INDIVIDUAL LEADERSHIP PLAN TO FOCUS THEIR LEADERSHIP. THE PROGRAM REACHES ABOUT 500 WOMEN A YEAR WITH A CLASS OF 20 TO 30 TAKING THE NINE MONTH TRAINING. THE PROGRAM PROVIDES OVER 4,000 HOURS OF SERVICE. THE IMPACT OF THE PROGRAM ON PARTICIPANTS IS TRANSFORMATIVE. THROUGH SEVERAL MONTHLY ASSESSMENTS, OBSERVATION, AND FOCUS GROUPS, THE PARTICIPANTS IDENTIFIED SEVERAL IMPACTS THAT SEEMED PARTICULARLY

WALKING IN TWO WORLDS (W2W) WALKING IN TWO WORLDS IS A PROGRAM TO HELP IMMIGRANT WOMEN AND THEIR FAMILIES NAVIGATE A NEW COMMUNITY. IT ALSO WORKS WITH THE GENERAL POPULATION TO BUILD AWARENESS OF IMMIGRANT ISSUES, THE IMMIGRANT EXPERIENCE AND BE MORE WELCOMING OF NEWCOMERS. THE GOAL OF THE PROGRAM IS TO BRING THE GIFTS AND TALENTS OF IMMIGRANT WOMEN TO THE COMMUNITY IN A MUTUALLY BENEFICIAL MANNER. IN 2010 THE PROGRAM CONTINUED A COLORFUL DIALOGUE. THIS IS A MONTHLY, FACILITATED CROSS CULTURAL COMMUNITY BUILDING CONVERATION. COLORFUL DIALOGUES HAVE BEEN ATTENDED BY ELECTED OFFICIALS, THE POLICE CHIEF, THE PRESIDENT OF THE UNIVERSITY, COMMUNITY MEMBERS AND ENGLISH LANGUAGE LEARNER CLASSES. THE CONVERSATIONS ARE ENJOYED BY ALL, BUILDING CROSS CULTURAL CONNECTIONS AND INCREASING UNDERSTANDING OF ONE ANOTHER'S

GIRLS ON THE RUN IS A NEW AND GROWING PROGRAM. IT IS AN INTERNATIONAL PROGRAM AND THE YWCA HAS AN AFFILIATE PROGRAM. THE YWCA AFFILIATE PROGRAM PILOTED IN SPRING 2008 WITH 12 GIRLS AND GREW TO SERVE 100 GIRLS AT SIX SITES IN 2009. IN 2010 THE PROGRAM REACHED OVER 800 PARTICIPANTS WITH 22,000 PROGRAM HOURS. 42% OF THE PARTICIPANTS RECIEVED A FULL OR PARTIAL SCHOLARSHIP AND 65% RETURN TO THE PROGRAM FOR ADDITIONAL SEANSONS. RESULTS INDICATE IMPACT. GIRLS THAT HAVE COMPLETED THE PROGRAM HAVE HIGHER SELF-ESTEEM, A HEALTHIER BODY IMAGE, AND A MORE POSITIVE ATTITUDE TOWARD PHYSICAL ACTIVITY. FOR GIRLS REPORTING THE POOREST SELF-PERCEPTION, BODY IMAGE, AND BEHAVIORAL AND EMOTIONAL PROBLEMS, CHANGES OVER THE COURSE OF GOTR WERE MUCH GREATER. THIS SUGGESTS A GREATER EFFECT FOR GIRLS EXPERIENCING THE MOST PROBLEMS WITH BODY IMAGE, SELF-PERCEPTION, AND BEHAVIORAL AND EMOTIONAL PROBLEMS.

THE PROGRAM ALSO CONDUCTS A CUSTOMER SATISFACTION SURVEY WITH ALL PARENTS OF PARTICIPANTS TO GAIN INSIGHT ON IMPACT FROM A PARENTAL STANDPOINT AND FEEDBACK ON WAYS TO BETTER MEET THE NEEDS OF GIRLS AND FAMILIES. GUARDIANS' SATISFACTION WITH THE PROGRAM WAS VERY HIGH, WITH ALMOST ALL GUARDIANS RATING ALL ASPECTS OF THE PROGRAM AS EXCELLENT OR VERY GOOD. MANY INDICATED A DESIRE TO PARTICIPATE AGAIN.

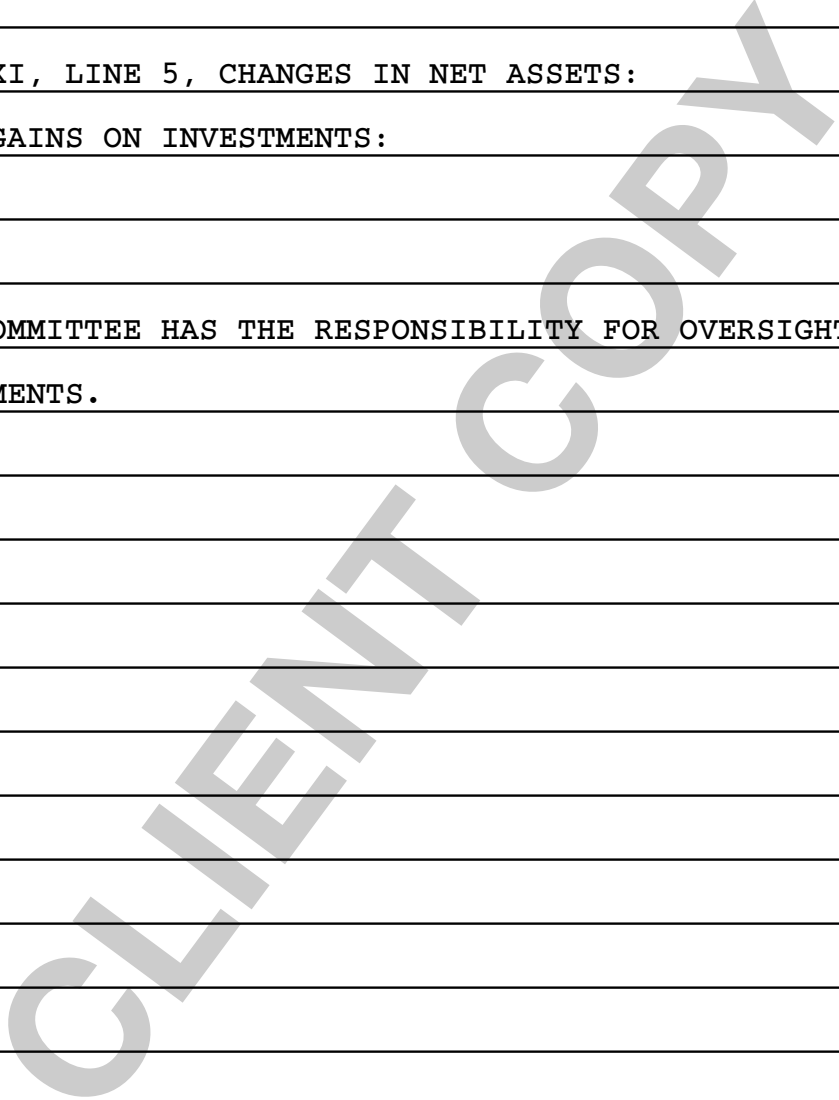
